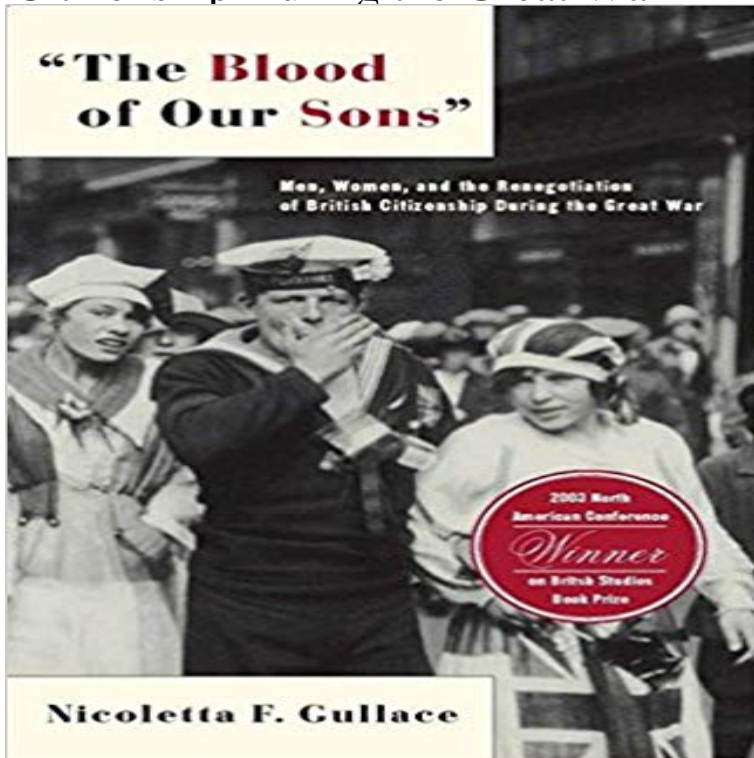


# The Blood of Our Sons: Men, Women and the Renegotiation of British Citizenship During the Great War

Drawing on the vast range of popular and official sources, Gullace reveals that the war had revolutionary implications for women who wished to vote and for men who were expected to fight.
